1. Willing candidates having requisite qualification as per Terms of Reference (TOR) in the website can apply in plain application with self-attested copies of all testimonial and 2 nos. recent passport size photograph and submit to the District Medical Officer of the interested district.
2. Application should reach the DMO office on or before 5 PM of 7<sup>th</sup> June 2020, and in no case, applications received after the stipulated time will be accepted.
3. Scrutiny of applications will be done on 8<sup>th</sup> June 2020.
4. The recruitment will be affected through Written test on 9<sup>th</sup> June 2020, followed by skill test on 4-5 basic skills as per Gol norm wef 10<sup>th</sup> June 2020 and overall process of recruitment to be completed by 13<sup>th</sup> June 2020.
5. The Venue for the test will be finalized by the DMO of respective districts.

6. On top of the envelope, the applied post should be mentioned bold letter & addressed to DMO.
7. All those candidates who have applied before need to apply afresh.
8. Candidates working in Govt./Pvt. sector will mandatorily require to submit NOC from appointing authority.
9. The recruitment will be done at the district level based on the allocation. However, the following districts may conduct the recruitment as below:






